

## COOKIE NOTICE

Bel Fuse Inc., and each of its affiliates and group members including Bel Fuse-Circuit Protection, Bel Magnetic Solutions, Bel Power Solutions, Cinch Connectivity Solutions, Signal Transformer, Stewart Connector, TRP Connector and Enercon Technologies (collectively, “**Bel Fuse**,” “**we**,” “**us**,” “**our**”) respect your privacy and are committed to protecting the personal data we collect or access through cookies or similar technologies.

By using our Services you acknowledge and agree to our use of cookies and other similar technologies to provide the Services (and related advertising, where permitted) to you as described in this notice and in our [Privacy Notice](#). Where required by applicable law, we will request your explicit consent before placing or accessing non-essential cookies on your device. ### WHAT ARE COOKIES AND PIXEL TAGS?

“**Cookies**” are small strings of text or computer code stored locally on your device that allow us, ad networks, and our third-party service providers, to identify your browser and/or device as you browse the Internet. Cookies can be placed, read, and/or written to by our Services, or other websites or services that recognize a particular cookie, which allows the website to “remember” or “recognize” a particular browser or device and, in some cases, store information about that browser or device.

Certain types of cookies or cookie-like functionality may be placed or activated through browser add-ons, including, but not limited to, Adobe Flash. While these cookies are stored differently, their functionality and purpose is generally similar to other cookies.

Cookies are often used in conjunction with “pixel tags” (also known as “web beacons” or “clear gifs”). Pixel tags are small, transparent, images embedded in web pages or emails that work alongside cookies and similar technologies to collect usage and engagement data. We, our analytics providers, advertisers, and other third parties can use pixel tags to interact with cookies and other tracking technologies to understand how users interact with our Services. For example, whether you open or engage with content in promotional emails or visit specific pages on our websites, which helps us evaluate and improve the effectiveness of our advertising and marketing campaigns.

### HOW LONG ARE COOKIES STORED ON MY SYSTEM?

**Session Cookies.** “Session cookies” are stored for the duration of a browser session; when you close the browser, the cookie is deleted.

**Persistent Cookies.** “Persistent cookies” are stored for a preset amount of time (often between 90 days and two years, depending on the application) and are typically not deleted when a browser session is closed.

Your choices may affect whether we use session or persistent cookies for a particular application. For example, ordinarily, by default, the Services store signed-in status using a session cookie, meaning you must log in again each time you start a new browser session. However, if you select “Remember Me,” your signed-in status is stored using a persistent cookie, which remains on your device until it expires or is deleted.

## WHAT COOKIES DO WE USE AND WHY?

As stated above, a cookie is a small piece of data (text file) that a website – when visited by a user – asks your browser to store on your device in order to remember information about you, such as your language preference or login information. Those cookies are set by us and called first-party cookies.

We also use third-party cookies – which are cookies from a domain different than the domain of the website you are visiting

In addition, we use digital pixels and similar technologies from third-party providers to collect technical information about your device and browsing behavior. When you visit our websites, these third-party providers may use these pixels to perform geolocation based on your IP address and to match your company against their database. If a match is found, the provider shares the visitor's country and company name with us. No personal contact information, such as individual names or email addresses, is collected or shared by the third party. This information helps us understand our business visitors and improve our Services. These cookies and pixels may collect data such as your IP address, browser type, and approximate location.

More specifically, we use cookies and other tracking technologies for the following purposes:

### Strictly Necessary Cookies

These cookies are necessary for you to browse and use the Services. These cookies are required for the Services (or certain functionalities) to operate correctly and are not used to collect personal data. Disabling these may result in repetitive or less relevant content and diminished user experience.

## HOW DO I CONTROL OR MAKE CHOICES ABOUT COOKIES AND TRACKING TECHNOLOGIES?

**Managing Cookies in the EU.** We will ask for your consent before placing any cookies or other similar technologies on your device, except where they are essential for us to provide you with a service that you have requested (see ‘*Strictly Necessary Cookies*’ in the table above). This includes all non-essential cookies such as analytics, performance and targeting cookies, which require your prior opt-in consent.

**Managing Cookies in the UK.** Under the Data Use and Access Act (DUA Act) 2025, we may place certain cookies and similar tracking technologies on your device without prior consent, beyond those strictly necessary to provide you with a service you have requested (see ‘*Strictly Necessary Cookies*’ in the table above). These include cookies and pixels used to collect anonymous, aggregated statistical data, improve website performance, support emergency assistance and maintain security measures such as fraud detection. These cookies may be set automatically, but you still have the option to opt out, or manage your preferences through our “Cookie Settings”. For all other cookies, including those used for targeted advertising or profiling, we will ask for your explicit, informed consent before placement.

**Withdrawing Consent or Changing Your Preferences.** You can withdraw your consent to the use of cookies (including digital pixels) or manage any other cookie preferences by clicking the “Cookie Settings” link in the website footers (where available). Alternatively, you can use your browser's privacy settings to clear cookies (usually found in the “Privacy” and/or “Security” settings).

Please note that removing cookies in your browser may not disable all tracking technologies, including pixel tags, unless consent settings are also updated under “Cookie Settings”. It may be necessary to refresh the page for the updated settings to take effect. This may cause the cookie preferences banner to reappear, letting you update your preferences.

Whether you are visiting from the UK or the EU, we will always ask for your clear, informed consent before placing cookies or similar technologies that:

- Collect any personal, business-identifying, or marketing data (such as your name, company name, or contact details);
- Are used for targeted advertising, profiling, or tracking across websites; or
- Are set by third-party providers who may use tracking technologies to analyze your visit and compare it with data in their own databases. We do not receive or access the raw data collected by these providers, but we may receive summary insights (e.g. visit frequency or location trends).

These types of cookies will never be placed without your prior opt-in consent, and you may withdraw that consent or update your settings at any time through the tools provided.

**Managing Cookies in the U.S.A.** Most browsers automatically accept cookies by default, but you can adjust your device and/or browser settings to delete and/or block some or all cookies, or provide notifications when you receive a new cookie. Consult the “Help,” “Tools,” or “Preferences” menus on your browser, or the documentation for your device, for more information about how to do this. Please note, however, that blocking or deleting certain cookies may negatively affect your user experience.

Additionally, you can generally disable or delete cookies placed and used by browser add-ons, by changing the add-on settings or visiting the website of its provider.

However, you may not have access to certain features and services (such as consistent volume settings for videos) that make your online experience more efficient and/or enjoyable.

**Advertising.** Some third-party advertising networks may use cookies and similar technologies to collect information about your browsing activities to deliver tailored ads.
