

In addition to the terms and conditions agreed to by the parties and included on the purchase order, the following Federal Acquisition Regulation (“FAR”) and Department of Defense FAR Supplement (“DFARS”) clauses shall apply as required as flowdowns to subcontractors of federal contracts. The effective version of the FAR or DFARS clauses applied to an order shall be the version in effect as of the date of the order, unless a different version is explicitly referenced.
